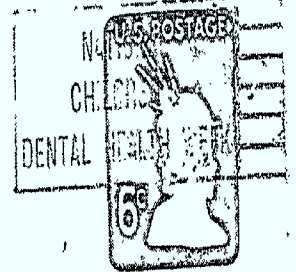
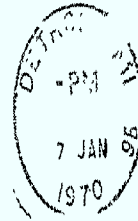

Girl addicts pass bad checks for Mafia, Boston paper says

BOSTON—(AP) — The Boston Globe said today more than \$1 million in counterfeit money, stolen postal orders and bank checks have been passed in the Greater Boston area in the last month by female drug addicts working for the Mafia.

The girls were paid at least \$200 a week, supplied with false identification to pass the checks, set up in motels and high-class apartments, and chauffeured to and from the areas they worked, the Globe said it had learned.

One girl, the newspaper reported, said: "pushing paper (hum money or checks) is an easy way to make money. I don't get any qualms over it. I just want the money for the drugs."

The girls, mostly teen-agers, the story said, were recruited by the Mafia on Boston Common, in the night club and theater district or in various narcotics hangouts throughout the city.

The counterfeits and other negotiables, the Globe said, were shipped into the city by the Mafia and distributed to members of the organization.

"You only work a few weeks at a time, because the clerks will recognize you, one of the girls was quoted as saying. "But you can always get a job later. They always can use somebody like me."

Police had no immediate comment.

U.S. NEWS & WORLD REPORT, Oct. 20, 1969

The Inquest Rules Kennedy Wants

BOSTON—Senator Edward M. Kennedy has asked the Supreme Judicial Court of Massachusetts to set ground rules for any inquest into the death of Mary Jo Kopechne.

Specifically, an attorney representing Mr. Kennedy requested:

- That the press and public be barred from the proceedings.
- That Judge James A. Boyle of the district court of Dukes County be disqualified from presiding.
- That Senator Kennedy be permitted a full legal defense by a lawyer empowered to cross-examine witnesses and object to evidence.

These requests were presented in a two-hour hearing October 8 before five justices of the Massachusetts court. An inquest had been scheduled for September 3 into the death of Miss Kopechne in Senator Kennedy's car last July 18. The inquest was postponed to let the State's highest court hear the appeal by Senator Kennedy.

Attorneys for Mr. Kennedy and nine other potential witnesses at the inquest argued that their clients' constitutional rights would be seriously compromised under rules set by Judge Boyle.

Senator Kennedy, his counsel said, would be "the focal point" in "an accusatory proceeding which could result in criminal action."

Joseph J. Hurley, an assistant attorney general who represented Judge Boyle, said an inquest could clear persons of suspicion. He added:

"Kennedy himself, on television, referred to innuendo and whispers and gossip. An inquest could serve to end this and to protect and clear the good name of Miss Kopechne as well."

There are enclosed herewith for receiving offices a true copy and a Xerox copy of an undated letter addressed to United States Senator Edward M. Kennedy, Boston, Massachusetts, 02108. Also enclosed is a Xerox copy of the envelope in which the letter was mailed. The letter was postmarked at New Paris, Ohio, on the morning of December 31, 1960, zip code 45347. This letter contains a threat to Senator Kennedy and may constitute a prosecutable violation of the Federal Extortion Statute. The original of the letter has been forwarded to the FBI Laboratory and Identification Division for appropriate comparison and latent fingerprint examination. You will be advised of the results of these examinations separately.

This threatening letter was received through established liaison channels from United States Secret Service headquarters, Washington, D. C. Secret Service has advised that two other anonymous letters similar to the enclosed letter were addressed to the President. These letters also were postmarked at New Paris, Ohio, on the morning of December 31, 1960, zip code 45347, and Secret Service is investigating the presidential threats. Illegible copies of the Presidential threats were forwarded by Secret Service and due to their poor quality are not being forwarded to interested field offices. The originals of these two letters threatening the President are currently in the hands of United States Secret Service agents at Cincinnati, Ohio, and copies can be obtained from them.

Cincinnati is instructed to immediately contact the appropriate United States Attorney and secure a prosecutive opinion. In the event prosecution is declined Cincinnati should submit results of investigation by return communication in a form suitable for dissemination. Boston, Alexandria and WFO should immediately advise local authorities of the threats to Senator Kennedy.

We have instructed field to secure a prosecutive opinion and to advise local authorities of the threat to Senator Kennedy. The Laboratory should conduct appropriate examination of the letter and the Latent Fingerprint Section should conduct a latent fingerprint examination in an attempt to identify the subject. The original of the letter should be sent thereafter to the Cincinnati Division.

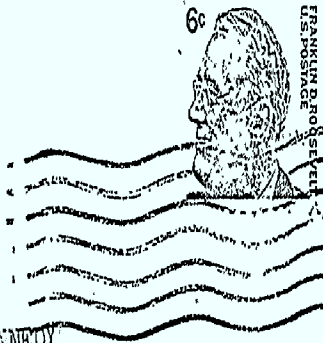

The letter is dated 12/3/69.

The letter contains a veiled threat against the life of Senator Kennedy. You should discuss a possible violation of the Extortion Statute with the office of the U. S. Attorney and handle accordingly.

The original letter has been submitted to the FBI Laboratory for appropriate examination. You will be advised of the results. For your information Bureau files contain two references to a [redacted] both of which are incoming telegrams dated 10/23/67, and 10/29/67. At that time, [redacted] used the return address of [redacted] St. Louis, Missouri. The telegrams indicated he believed that the Government was tampering with his retirement and that his personality and actions were controlled by drugs.

Senator Kennedy,

May I introduce myself; I am [redacted] SS [redacted]

For the past three years I have conducted a private research into the riots, violence, disorders and assassinations in America. My findings are official documented facts. Some of my discoveries disclosed the recent attempt to murder you. That your accidents of the 60s were not accidents but attempts at your life. Other facts prove that your family tragedies are not the unnatural acts of fate but are man made disasters, designed to destroy you and are aimed at the wealth of your family; as similar schemes are directed at the wealth of other American families.

(My facts include: 1. You are marked for death in the very near future, I would say in the spring, 1970.) 1b. You could not have caused the death of the Kopechne girl in July, 1969. Officer [redacted] observed another man and woman in your car just before it was reportedly wrecked. This indicates that there was a plot to gain a witness to your being with Mary Jo at a certain time, thus, establishing you were with her in the car at or near the time the event was to be reported. His accurate recognition of the cars occupants saved your life. Mary Jo was probably already dead at the time. 1c. Alcoholic beverages are not the only means of getting intoxicated. The symptoms you mentioned to the press as experiencing after the alledged wreck of your car are also listed symptoms of Carbon monoxide intoxication, i.e. loss of memory, loss of the ability to recall, avoidance of unfamiliar situations. During the evening of the cook out you were exposed to elements that would cause carbon monoxide intoxication. 62-112941

2. Therefore, two persons known as Lee Harvey Oswald, working in the Texas School Book Depository in Dallas, Texas on the late President John F. Kennedy, was shot.

3. The same conspiracy caused the death of Senator Robert Kennedy, in Los Angeles, California, in 1968. I was in Los Angeles at the time and had written to the Senator informing him of some of my findings at the time, however, he was shot before I could see him in person. 3b The conspiracy is in great evidence here in that the slayer waited for his victim in the most unlikely place in the city to way-lay and shoot him; the kitchen of the hotel where a campaign party was planned. The Los Angeles papers reported the slayer waited for over an hour to shoot the Senator, this indicates the slayer knew before the Senator the exact kitchen section and the exact kitchen approach he would be coming, and the approximate time he was due. It further demonstrates the slayer knew the outcome of the close political race as much as 3 days before election. (This is assumed because the slayer was reportedly seen practising firing his weapon 2 days before the election day results.)

4. Kennedy men of the age of consent are destined-marked for a early demise in order that the Kennedy fortune will be easier to control. 4b. By destroying the Kennedy family they destroy the American image of close family, youth, successful goals, wealth. 4c. By slaying the Kennedys a symbolic image will arise displaying distaste for wealth and public office. 4d. Physical assassinations and character assassinations are added effects to discredit our democratic form of government; e.g. the man, the office, the government, the system.

I wrote to the head of the Democratic Party in this city in August, 1969 asking them to notify you of this plot against your family.

This is a ultra form of degregation in this the age of symbolism; e.g. motivation by audio-visual means of communicational learning to the exclusion of personal tests of logic, reason, school curriculums, trial and

error, etc.; to solve problems.

I cannot advise a protection but I strongly advise you seek the full protection of the law Congress passed in 1950 that was designed to protect Presidents and Senators. If it was not passed, then, the law enforcement authority of the government will advise you.

It is not my intentions to frighten you but to warn you. I am personally familiar with the horror you must have suffered during the dark hours of harried mental confusion on that morning in July, 1969. e.g. you were reported as saying that you were not clear on exactly what happened and you probably never would recall it fully. These are indications that your actions were directed and probably the statements of the incident. You actually admitted committing acts you were not certain you performed. It can be explained. It was a state of condition much like a alcoholic state but it is not a alcoholic state. It is a form of hypnotism.

All of my findings are officially documented. I will send you details as I have found them within ten days of the date of this letter. I have no other means of communicating with you and shall not use any other except writing.

I ask no fee.

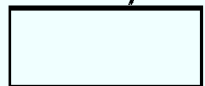

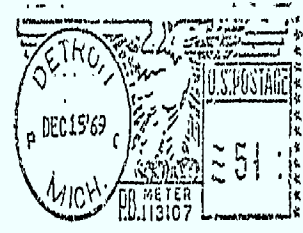
